AKKREDITIERUNGSRICHTLINIEN / ACCREDITATION GUIDELINES

Mit der Akkreditierung gewährt der Veranstalter den Medienvertretern Zutritt zu Bereichen, die gefährlich sind und daher für sonstige Zuschauer gesperrt sind. Die Akkreditierung, vor allem für Fotografen/TV, erleichtert journalistisch arbeitenden Kolleginnen und Kollegen die Arbeitsbedingungen. Nur diesem Personenkreis kann der Veranstalter die Erlaubnis erteilen, sich nach Rücksprache mit den verantwortlichen Streckenposten vor Ort, in ansonsten gesperrten Bereichen aufzuhalten.

Eine Akkreditierung kann nur Personen erteilt werden, die einen Nachweis ihrer journalistischen Arbeit erbringen.

Für Fotografen werden in diesem Jahr wieder Pressewesten ausgegeben, für die ein Pfand in Höhe von 20.- Euro zu hinterlegen ist. Diese Westen sind Bestandteil der Akkreditierung.

Eine Entscheidung über die Erteilung einer Akkreditierung trifft ausnahmslos der Veranstalter!

With the accreditation, the organizer grants the media representatives access to areas that are dangerous and therefore are blocked for other spectators. The accreditation, especially for photographers / TV, makes it easier for journalistically working colleagues to work. Only this group of persons can give the organizer the permission to reside on the spot, in otherwise restricted areas, in consultation with the responsible local authorities.

An accreditation can only be given to persons who provide proof of their journalistic work.

For photographers this year press releases will again be issued, for which a deposit of 20.- Euro has to be deposited. These vests are part of the accreditation.

A decision on the granting of an accreditation is made by the organizers without exception!

MEDIA REPORTS STATEMENT

§ 1

I am aware of the risks arising from cycling, especially downhill events, and I undertake to comply without delay with the regulations and instructions (written, oral and optical) issued by the organizers, the race management, the sports clubs, the police and their representatives. And in particular, not to enter blocking zones, crash zones and safety strips.

§ 2

I acknowledge that I am acting at my own risk if I leave the area generally accessible to the spectators and the places expressly designated by the race management, also to the extent that the stay there is tolerated by the organizer and his plenipotentiaries.

Explicitly stated by the race management are:

- all auditoriums designated as such
- the entire paddock area including all links

It is known to me that the stay is strictly forbidden in front of the barriers, in security zones, in sturgeon zones, on safety strips and obvious hazards.

§ 3

I hereby declare, with the submission of the media report, the waiver of any claims for damages arising in connection with the event against

- UCI, Federation of German Cyclists, their presidents, organs, managing directors, secretaries-general, board members, advisors, employees and members,
- the organizers, their representatives, sports teams and assistants,
- the owners of the routes and their representatives,

- the drivers and their assistants,
- authorities and other persons or institutions related to the organization of the events.

Liability waiver does not apply to damages resulting from injury to life, body or health, to other damages which are caused by willful or grossly negligent breach of duty as well as not to damages resulting from a breach of an essential contractual obligation by the group of persons. In the event of damage resulting from a negligent breach of contractual obligations, the liability for property and property damage shall be limited to the typical, foreseeable damage.

The liability loss applies to claims arising from any legal grounds, in particular for claims for damages arising from contractual and external liability and for tort claims.

Non-binding disclaimers shall remain unaffected by the foregoing disclaimer.

§ 4

I am aware that violating the above paragraphs will lead to the withdrawal of my media accreditation and may lead to legal consequences.

The exclusion of liability shall be effective with a charge against all parties.
